



## For the Week of January 29, 2018

Planning and Zoning Department Sarah Hadd, Director

- The Colchester Development Review Board will meet on February 14<sup>th</sup> to consider the following applications:
  - 1) Preliminary plat application of Cosimo and Sandra Lomatire and Rivers Edge Building Development, LLC for a 50 unit, 28 lot planned residential development on an existing 48 acre parcel developed with a single family residence located at 634 Malletts Bay Avenue, tax map 6, parcel 5
  - 2) Final plat application of Rivers Edges Building Development for an amendment to a previously approved subdivision for a 45-unit, 22-lot planned unit development in which the amendment consists of:
    - a. reduce lot #2 from 16,802 sq. ft. to 11,916 sq. ft. and remove single family residence to allow for future road connection;
    - b. increase lot #1 from 22,905 sq. ft. to 27, 815 sq. ft. and construct a duplex;
  - c. increase the depth of lots 36 43; and 4) increase lot #13 from 19,166 sq. ft. to 31,363 sq. ft. located at at 0, 129, 147 and 317 Annas Court, tax map 6, parcels 8, 8-1, 8-2, 8-13;
  - 3) Site plan of Joey and Marcia Purvic and the Grass Gauchos to construct a 30' x 50' building and establish a landscape contractor's yard at an existing site developed with a mix of residential, storage and retail located at 1847 Main Street, tax map 22, parcel 174.
- The Selectboard approve Supplement 41 on January 23<sup>rd</sup>. This supplement will combine the Zoning and Subdivision Regulations and will become effective on February 14<sup>th</sup>. The Board also approved changes to the recreation impact fee. This fee on new residential units will create a tiered structure for single family, multifamily, and affordable housing units that will gradually increase the fee over a five year period. This change also becomes effective February 14<sup>th</sup>.
- The Planning Commission will meet again on February 6<sup>th</sup> to continue their review of the existing Town Plan focusing on the Housing Chapter. A formal visioning process is anticipated to kick off the 2019 Town Plan in May with subsequent issue and place based forums.
- Get Engaged Program: A reminder, the Planning Commission could still use a student member. High school students who are residents of Colchester are encouraged to apply through the Colchester Town Manager's Office.
