Masks in Public Spaces: If you are walking/biking on sidewalks, paths, trails or other outdoor public spaces--where you will not be at least six feet away from people who do not live with you--please bring something with you and pull it up over your nose and mouth as you pass within six feet of others. Please be especially considerate of others wearing masks outside as this indicates they would not want to come into contact with others without masks. This is a courtesy and expectation under the current state of emergency and Governor's Orders.

The arrival of the Tenth Cavalry sent Burlington into demographic shock. Almost overnight the small city acquired a substantial black community, a situation that clearly dismayed many residents. In July 1909, the Tenth United States Cavalry Regiment, one of four regular army black regiments collectively known as the Buffalo Soldiers, arrived in Colchester to begin a four-year tour of duty at Fort Ethan Allen. Many people feared the presence of sizable numbers of African American soldiers in their community and a bitter debate ensued over whether the City of Burlington should adopt Jim Crow facilities. For the next four years, the Tenth Cavalry would encounter similar reactions as it traveled throughout the northeast and as far south as Winchester, Virginia. Wherever they went, the black soldiers faced fear and suspicion and had to demonstrate good behavior to win the acceptance of the white population. January 26 Colchester Selectboard Meeting Highlights: Your Town Selectboard

- Approved the 2022-2027 Capital Budget Program to be reviewed by the Planning Commission and to hold a public hearing on the program on March 23, 2021. The Capital Budget Program consists of a capital budget which lists and describes the capital projects to be undertaken during the coming fiscal year, and a capital program which is a plan of capital projects proposed to be undertaken during each of the following five years.
- Agreed to a no cost loan of a fire boat from the State of Vermont for use by the Town Fire Department.
- Accepted proposed changes to the Town's Ethics Code by the Town Board of Ethics
- Heard an update from the Fire Chief Bourgeois on the Department staff and equipment

COVID UPDATE:

Unemployment: During the current economic crisis caused by COVID-19, the unemployment rate rose extremely fast—declined quickly and is beginning to rise, at least in Colchester and Vermont. Initially, the Colchester unemployment rate rose from 1.9% to 13.3% in two months. We are now at 2.3% unemployment. Vermont is tied for third lowest rate with lowa, just behind Nebraska and South Dakota (3.0 percent).Info on past downturns: https://colchestervt.gov/ArchiveCenter/ViewFile/Item/693

The 2.3% unemployment represents people who are actively looking for a job. The unemployment rate would not include people who cannot work due to lack of childcare or a variety of other reasons. In December 2020, 6.5% or 687 fewer Colchester residents were working than in December 2019. There are 110 or 1.1% fewer people working in December 2020 than there were in November 2020. Though written for the Montessori-minded, Haughey's book features projects all children will enjoy. More importantly, they provide caregivers the opportunity and instruction to step back and let the kids explore the mediums and process on their own. If you're a Type A like me, you want a neat work area and an obvious final product. But as anyone who has ever met a child can tell you—children are not neat! It is this very characteristic that makes them and their artwork so honestly beautiful. Story blocks, crushed chalk paint, and tube sculptures are just a few of the explorative ideas you will find in this book. So buy a thick plastic tablecloth, rustle up some craft supplies, take a few deep breathes, and let the kids make a mess.
