Community Justice Update

One part of the Town of Colchester's community justice efforts includes funding the Essex Community Justice Center (ECJC) in partnership with the Town of Essex and the State Department of Corrections.

ECJC provides restorative justice programming

with a focus on crime prevention, conflict resolution, and meeting the needs of those affected by crime. Different programs include Community Restorative Justice Panels, Community Dialogue education, and the Circle of Support and Accountability Program (COSA), which helps those recently released from incarceration to successfully re-enter society.



In their spring newsletter, ECJC noted the largest trend in the Community Restorative Justice Panels since the onset of the COVID-19 pandemic is a 60% increase in the number of referrals from Law Enforcement and the State Attorney's office. They explain this increase is due to the Chittenden County State Attorney's decision to send more cases to the ECJC while the courts remain closed during the pandemic.

At this time last year the pandemic was still relatively new to us. Our office had closed to visitors and our panel and CoSA meetings had begun meeting via Zoom. In our community,



schools were closed, people were losing jobs and Vermont's unemployment website crashed, there were start-up mask sewing enterprises everywhere, virtual social gatherings were becoming more popular, the National Guard was distributing MREs, we all had learned what PPE stood for, there was toilet paper hoarding, and there were debates about who should be seen as an essential worker.

Vermont Forward Plan Advances to Step 2:

With more than 61% of Vermonters 16


and older now vaccinated with at least one dose, the state has cleared the criteria to enter Step 2 of the state's Vermont Forward reopening plan. Gatherings will now be allowed to have up to 150 unvaccinated people indoors with spacing and 300 unvaccinated people outdoors. Any number of vaccinated people may gather. Masks



and physical distancing are still required when not with your household. Restaurants and bars, hair salons, churches, gyms, museums and theatres, and manufacturing will move to the universal guidance.

Daily case counts are still falling state-wide as vaccination rates increase. According to the <u>latest modeling</u> by the Department of Financial Regulation, cases are down 61% in April:

When You've Been Fully Vaccinated:

The CDC announced new guidelines last week for those who have been fully vaccinated. Their definition of fully vaccinated means at least 2 weeks after either the second dose of the Pfizer or Moderna vaccine, or 2 weeks after the single-shot Johnson & Johnson vaccine.

After those two weeks, fully-vaccinated people can


loosen mask-wearing restrictions outside, visit with other full-vaccinated people indoors without masks, attend a small, outdoor gathering without a mask, and more. Additionally, those fully-vaccinated can refrain from testing or quarantine before or after domestic and international travel (unless required by the destination).

Fully-vaccinated people, however, should still continue to take precautions by

wearing a well-fitting mask in indoor, public settings, as well as at crowded outdoor events, according to the CDC. They should also still take precautions if visiting with unvaccinated people from multiple households, as well as those who are unvaccinated and are at increased risk for COVID-19.


Vaccination Progress

All Vermonters aged 16 and older are eligible to receive the vaccine. You may set up an account with the Dept. of Health to register for a vaccine <u>here</u>.

As of Saturday, May 1, 340,715 Vermonters, or 62.3% of the state's population have had at least one dose of the vaccine. 238,800 Vermonters, or 43.7%, have been fully vaccinated. View the COVID-19 Dashboard here.
