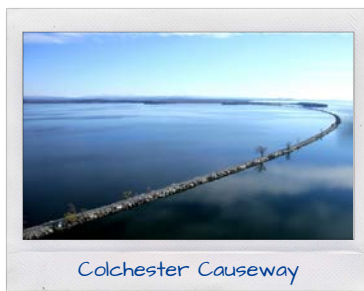

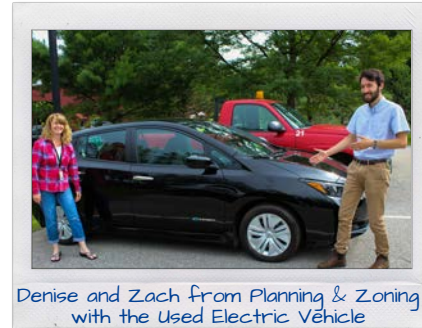


84.9% of Chittenden County residents 12+ have received one dose of a COVID-19 vaccine as of July 16, 2021.

Local Energy Update

- The Town recently purchased a used electric car to replace a small sport utility vehicle (SUV). Not only will this used vehicle be less costly for the Town to maintain and operate, but Colchester will also benefit from the federal tax credits collected by the previous private owner.
- The Chairs of the Selectboard and Planning Commission signed a letter of support for the development of Colchester's third solar farm at Sunny Hollow Natural Area.
 - This would allow the Town to produce electricity equivalent to 60% of that used to provide municipal services from cost-effective, affordable, and local sources.
 - The three projects will save over \$1.35 million in electricity costs over the lives of the projects.

L. dispar Moth Update



The Town checked in with Joshua Halman, a Vermont (VT) Licensed Forester and Forest Health Specialist, regarding the State's moth outbreak. Currently, the VT Agency of Natural Resources (ANR) is collecting aerial images of affected areas.

At this time, most larvae caterpillars have transitioned into adult moths. Therefore, Colchester residents should not be concerned by the potential of further tree damage this year, especially with the mating season just around the corner. Remember, the species dies after mating and laying egg masses, which remain during the winter season.

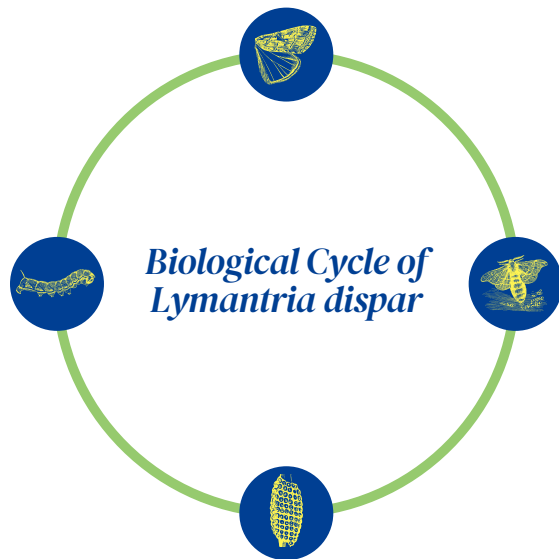
VT ANR's current plan of action is to monitor and survey these egg masses. There is no intention of employing a state-run spray program similar to the one conducted a couple of decades ago at this stage.

Judy Rosovsky, Vermont State Entomologist, explained that trees could survive a year or so of defoliation. But, defoliation and dry weather are stressors on tree, shrub, and plant health. Therefore, keeping your plants watered will help offset defoliation stress. Colchester may see another year or two of high levels of moths unless the Town gets some rainy seasons, which should increase the moth killing fungi.

Vermonters interested in exploring management practices are recommended to visit the following webpage, vtinvasives.org/invasive/gypsy-moth, for further information. Options include the hand removal of egg masses, chemical treatments, and burlap traps.
