#### **Colchester Planning Commission**

## What is the Colchester Planning Commission?

The Colchester Planning Commission is a five-member board of Colchester citizens who are appointed by the Selectboard. The Commission is tasked with updating the Town Plan as needed or required by statute, undertaking planning studies, participating in regional planning issues, and overseeing revisions to the Colchester Development Regulations. The Commission may also prepare and present to the Selectboard on these issues. Colchester's Planning



Commission develops plans, policy and regulations related to land use. Actual development projects are considered by a separate board, the Development Review board, utilizing the Planning Commission's regulations. Recently, the Commission has been working towards amendments to the zoning regulations for East Lakeshore Drive.

Planning Commission meetings are generally held scheduled for the third Tuesday of each month at 7PM at the Colchester Town Offices and are open

to the public. Meetings may be added or rescheduled as needed. Meetings typically average one to two hours in duration. The Planning Commission works with the Director of Planning and Zoning who attends each meeting and provides general staffing. The Commission's agenda is generally set by staff at the direction of the Commission and in consultation with the Commission Chair and Selectboard.

### What are the responsibilities of a Commissioner?

Ahead of the meeting, each planning commissioner is responsible for downloading their meeting packet that includes an agenda, staff notes, and other enclosures prepared by the Director, usually with recommendations for action. Packets generally require one to three





hours' worth of review prior to the meeting. Commissioners are often required to think through a variety of policy, legal, and community impacts of any Commission decision. Familiarity with local and state land use regulations, building design, or natural resources is helpful, but not required.

The Commission follows Roberts Rules of Order, but tries to be as informal when possible. All meetings are recorded, public, and can be seen on Channel 17 or found here



<u>https://lcatv.org/colchester-planning</u>. Interaction is required with other commissioners, staff, and members of the community.

## Why and how did current members begin volunteering with the Planning Commission?

"I started volunteering on different Town boards to be able to give back to the community where I live and work, and when I was asked to give the Planning Commission a try, I agreed, as I was looking to join a board that has a positive impact in moving Colchester forward."
