## **Broadband Opportunities and Challenges in Colchester**

Since Act 71 was signed into law in June 2021, Town staff have been working to identify a method for Colchester to avail itself of the significant amount of federal funds the State is distributing for broadband expansion. Through extensive research and analysis of Act 71, it has become clear that the framework it created for the distribution of funds is not a good fit for many Chittenden County communities, including Colchester. Challenges with Act 71 include 1) a mismatch between the funding allocation formula and the actual



costs of broadband deployment in non-rural areas that results in a very small share of federal funding being available to Colchester, 2) a requirement for a Universal Service Plan that makes solving the broadband issue in Colchester nearly impossible for small internet service providers, and 3) a prohibition against providing funding to large internet service providers (like Consolidated Communications), who may offer the most efficient broadband solution, unless a town is a member of a Communications Union District (CUD). Moreover, Act 71 and the associated grant programs for broadband are strongly rooted in the CUD model, which involves at least two towns voting to create a new unit of regional government (a CUD) for the purpose of building communications infrastructure, which requires management, administration, and oversight.

Given the relatively small number of Colchester addresses (under 150) that are deemed unserved or underserved according to the State's definition of broadband, staff have been reluctant to propose the Town join a CUD and take on the ongoing duties of CUD membership. However, it has become clear to staff that it will be virtually impossible for Colchester to access the current allocation of federal funding for broadband that the State is in the process of distributing without joining a CUD. Staff provided the Selectboard with an update on this conclusion at their meeting on June 28th. At that meeting, members of the Selectboard questioned the appropriateness of the CUD model for Colchester and noted the important differences between building broadband infrastructure in Colchester versus in more rural communities. Additionally, members of the Selectboard noted that due to the current funding allocation formula, the amount of federal dollars that would be available to Colchester even if it joined a CUD is quite limited, in the range of only 3.5-6.5% of the total estimated cost to bring broadband infrastructure to Colchester. This relatively small amount of public funding calls into question whether a CUD in Chittenden County could offer a financially viable solution for the broadband issue. By comparison, in more rural communities, State-provided federal



funding for broadband projects can be as high as 60% of the total cost. In these more rural areas, there is clearly a greater alignment between responsibilities of CUD membership and the potential benefits a CUD offers, and it appears in some rural parts of the State, CUDs are finding some early success. At this time, due to the uncertainty about the benefits CUD membership would offer Colchester and concerns about ongoing CUD responsibilities, the Selectboard is not actively pursuing CUD membership. Staff will continue to monitor the CUD discussions in Chittenden County and if a CUD is created, Colchester will evaluate whether membership makes sense at that time. For more information:
