## **Colchester Historical Society Wins Award of Merit**

The Colchester Historical Society is proud to announce that they were recently presented the League of Local Historical Societies & Museums Award of Merit from the Vermont Historical Society for their Self-Guided Historical Driving Tour.



Inspired by the COVID-19 health pandemic and the inability to hold in-person programs and meetings for more than a year, the Self-Guided Historical Driving Tour provides people with an opportunity to get out-and-about in a fun and safe way to explore and learn about many of Colchester's wonderful historical sites. The great advantage for participants is that the tour can be done on their own time, at their own pace, and without any fees.

The tour includes over 40 local historical sites and, for ease of use, is divided into four broad geographical areas: Colchester village area, Mallett's Bay area, Fort Ethan Allen area, and Airport Park area. There is an additional section that includes six of Colchester's local cemeteries. For each location, the physical address is included, and in some instances a map has been provided. It was noted that our driving tour offers an example for local historical societies who may be geographically expansive and cannot create a more traditional walking tour, as well as "a commendable example of how a small organization responded creatively to pandemic limitations."

"We extend our thanks and appreciation to the Vermont Historical Society for this recognition as well as to the several local volunteers who worked on this project to make it a wonderful, on-going success," said Bonnie Potter, President of the Colchester Historical Society.



# ATS: How does the Finance Department help operations run smoothly for the Town?

LA: The Finance Department is responsible for maintaining accurate, current and reconciled financial information. Our financial data can be used and relied upon at any point to make day-to-day or future resource decisions. Budget and actual reporting is available to all departments for tracking throughout the fiscal year. Financial



information is provided publicly monthly in Selectboard packets, and our audited financials are presented by a certified public accountant serving as an external auditor at a Selectboard meeting. The accuracy and ease of obtaining information is essential to keep operations running smoothly.



# ATS: What does a day or year look like for you and the Finance Department?

**LA:** Most days you would walk into the Finance Department to see staff preparing vendor checks, processing payroll, posting journal entries or reconciling accounts. The larger focus of the department changes depending on whether we are preparing for audit, budget preparation, the closing of fiscal year-end or the processing of year-end tax information. Overall, the processes within the department are cyclical, whether biweekly, quarterly or annual.

# ATS: What does collaboration with other departments look like for you and the Finance Department?

**LA:** The Finance Department is unique because it works closely with every department in some way. On a routine basis, we are collecting information and communicating with every department to issue accurate payroll and vendor checks. Frequent communication regarding budget revenues and expenditures, progress on grant use and procedural changes is essential to keep us on track and to receive clean audits.

ATS: What has been the most impactful project the Finance Department has been a part of (past, ongoing, or future)?



**LA:** Although it's not a "project," I believe the most important role the Finance Department plays is obtaining clean audits. It is essential that our financials and our systems are found to be accurate and there is integrity in the information that we present to the public.

Beyond the audit, I believe that our recent change to bi-weekly payroll has made the largest impact on how our department functions. Moving away from a weekly payroll cycle has saved on multiple resources.

# ATS: What is something the community might not know that the Finance Department does to help the Town operate?



**LA:** I find that there is usually confusion about what the Finance Department does versus what the Clerk/Treasurer's Office does. Within the Town of Colchester, Finance does not handle incoming cash for any reason. The Clerk/Treasurer's Office handles most revenue intake, including the Town's Municipal Services Taxes and the State of Vermont's Education Taxes. Finance is responsible for auditing and tracking the incoming revenue collected by the Clerk's Office and reconciling the bank accounts for accuracy. Separating these duties provides for important checks and balances. Ultimately, finance puts in place policies and procedures to safeguard the Town's assets.
