
Manager's Message

The Town of Colchester has completed its Annual Town Report. In just a few weeks Town Meeting Day will be here, and your Town Staff wants you to be informed about when, where, and how to vote, and what you are voting on! In-person and absentee/early voting will be available, and we encourage Colchester voters to request an absentee/early ballot ahead of time to be mailed or picked up at Town Hall.

WHEN & WHERE TO VOTE IN-PERSON: Tuesday, March 7, 2023 from 7:00 a.m. to 7:00 p.m. at the Colchester High School Gymnasium, Laker Lane.



WHEN, WHERE, & HOW TO COMPLETE ABSENTEE/EARLY BALLOT VOTING:

- Visit My Voter Page, https://mvp.vermont.gov/ to set up your personal voter account to request an absentee ballot be mailed to you directly. From this website, you can track your ballot until it is received and counted.
- Call 802-264-5520 to have your absentee ballot sent by US Postal Mail. Return by mail using the provided return envelope, and be sure to allow time for postal transit!
- Come in to the Town Clerk's Counter M-F 7:30 a.m.-4:30 p.m. to request an absentee ballot.
- Colchester Election Early/Absentee Ballot Drop Box is located at 781 Blakely Rd. between the Town Hall and Police Dept. buildings.

NOTE: Please be sure to put your voted ballot into the Certificate Envelope and complete the signature section before you drop off. Ballots must be received in the Town Clerk's Office by 12:00 p.m. or the Drop Box by 4:30 p.m. on Monday, March 6, 2023. These voted ballots sealed in completed Certificate Envelopes can also be dropped off at the polling location (Colchester High School) on Election Day until 7:00 p.m. There will be a drop box at the Help Desk.

BALLOT ITEMS:

Colchester Recreation Center

"Shall general obligation bonds or notes of the Town of Colchester in the amount of \$6,907,000.00, subject to available grants-in-aid, be issued under Section 703(c) of the Town Charter and Subchapter 1 of Chapter 53 of Title 24, Vermont Statutes Annotated, payable from the existing 1% local option sales tax over a period not to exceed ten years, and shall the Town use \$9,000,000.00, in previously collected local option sales taxes that are restricted to voter approved capital projects, for the construction of a Recreation Center?"

- The proposed Colchester Recreation Center is a 29,427 sq. ft. multi-generational facility and responds to a community need that has been identified over the past 20 years through multiple surveys, community outreach and engagement.
- This project will be paid entirely from the current and future proceeds generated from the existing 1% Local Option Tax (LOT), approved by voters in 2015 for financing of existing or future voter-approved capital projects.
- NO PROPERTY TAXES will be needed for this project.
- Membership and facility use fees will cover the ongoing operating expenses.
- NO PROPERTY TAXES will be used for operating costs of the Colchester Recreation Center.

Town Municipal Services Budget

"Shall the voters of the Town of Colchester approve total general fund expenditures of Fifteen Million, Twenty-Eight Thousand, Three Hundred Eighty-Six Dollars (\$15,028,386) of which Twelve Million, Six Hundred Twenty-Two Thousand, One Hundred Eighty-Nine Dollars (\$12,622,189) shall be raised by taxes and Two Million, Four Hundred Six Thousand, One Hundred Ninety-Seven Dollars (\$2,406,197) by non-tax revenues for the Fiscal Year July 1, 2023 through June 30, 2024?"

- Estimated to increase the municipal services tax rate by 5.7%.
- Maintains current level of municipal services and addresses additional resource needs in Information Technology (IT) due to expanding cybersecurity threats, increased service fees for departmental specific software and internet connectivity, as well as a Civilian Evidence Technician in the Colchester Police Department and additional resources required for data storage and transmission for Body Worn Cameras and Digital Evidence Software.
- Residential Municipal Services Property Tax Impact: For a property valued at \$300,000, the increase would be\$99/year or \$1.90/week.

RE: Letter of support and finding of compatibility for proposed Community Recreation Center

Dear Members of the Colchester Selectboard,

On behalf of the Colchester Planning Commission, I would like to assert support for the proposed Colchester Community Recreation Center, as presented by the town's Recreation and Parks Director and Recreation Advisory Committee. Our support for the project is aligned with the proposal's compatibility with the Town's vision, current land use, and future land use goals.

We find that the proposed recreation center is compatible with the 2019 Colchester Town Plan. In fact, the support within the plan appears early and often. The plan's introduction states that,

Proud of the quality of life enjoyed here, the people of Colchester seek to build upon this foundation to ensure economic prosperity, **recreational opportunity**, and an entrepreneurial spirt for future generations."

With respect to the Inner Bay neighborhood, where the existing Bayside Park facilities are and where the proposed recreation center would be located, the Town Plan states that:

Services and recreational access for residents and tourists should be improved.

The Town Governance chapter of the 2019 adopted town plan speaks to a town recreation center directly:

The Bayside Hazlet and Bayside parcels must be developed to make room for the recreation center.

Policy #3 of that chapter:



3. Make improvements to Bayside-Hazlett property and Bayside Park, ultimately leading to the creation of an indoor recreation facility.

And Action 7 of the same chapter:

7. Advance the Bayside-Hazlett project as funding allows, and continue the recreation impact fee in support of the needs of a growing community.

And the goal of the Cultivating Colchester chapter:

Colchester will continue to be a recreation destination with equitable access for all, making it a healthy community to achieve physical, mental, and social wellbeing.

Action item:

3. During the term of this plan, the first phases of the Bayside Park Master Plan are anticipated to be implemented, resulting in increased recreational offerings benefiting the community.

The 2019 Town Plan, drafted by the community, advanced by the Planning Commission, and voted affirmatively for adoption by the Selectboard, fully supports the development of a Community center at the Bayside Hazelett site. The proposal has the support of the Planning Commission for compatibility with this important community-driven plan.
