Dear Colchester Resident,

We, as your elected Colchester Selectboard, are writing to ask for your support of the Colchester Recreation Center, Article #7, on the upcoming Annual Town Meeting Election Ballot.

The Selectboard recognizes the immense value recreational opportunities and amenities bring to the community, which is why we are asking you to consider this proposal. This project came to fruition after 20 years of community engagement and outreach, and it will respond to the identified need for more multi-generational, multi-purpose, indoor recreational and group gathering spaces.

The proposal for this 29,427 sq. ft. facility located on the Town-owned, 14-acre Bayside/Hazelett property includes multi-purpose exercise and gathering spaces, including a gym, track, weight room, studio space, classrooms, a kitchen, and locker rooms. With more recreational and community gathering spaces, active and vibrant lifestyles for all ages can be encouraged for years to come, and businesses too will benefit, as a year-round facility will bring people to our commercial center.

We still remain focused on fiscal restraint for the benefit of all taxpayers, which is why this project's funding is another benefit. We are seeking voter approval for \$15,907,000 to fund construction, but there is \$9 million in Local Option Tax (LOT) (1% sales tax) available in reserve for this project, and the remaining \$6,907,000 will be financed over 10 years and repaid with LOT funds. This results in NO increase in property taxes to support or construct the facility and NO increase to the LOT (repayment is funded with existing 1% sales tax). Additionally, Recreation Center operations will be funded by memberships and facility rentals.

With these positives in mind, the Selectboard urges you to vote YES on this project, as Colchester's health, economy, and social fabric can only benefit from the Colchester Recreation Center.

**Colchester Historical Society Remembers the "Buffalo Soldiers" of Fort Ethan Allen**: In honor of Black History Month, the Colchester Historical Society presents this information about the 10th U.S. Cavalry at Fort Ethan Allen.

Nicknamed the "Buffalo Soldiers," the 10th U.S. Cavalry served a four-year assignment and were stationed at Fort Ethan Allen in Colchester. It was one of the first peacetime all-black regiments established in the regular U.S. Army after the Civil War. There were 750 black



enlisted men; however, the actual number of black Americans arriving was higher – around 1,500 – because the regiment had a large camp that included wives, children, and other relatives and followers.


Many of these new families became involved in their local communities and some settled here. The Winooski United Methodist Church, built in 1860, became the home church for many. According to a *Burlington Free Press* article by April Barton (July 26, 2022), at least four soldiers retired from the Army and decided to stay in Winooski and remained members of the church. Sadly, in 1917, the church burned to the ground; however, the Buffalo Soldiers were instrumental in its rebuilding. In 2001, the church was placed on the U.S. National Register of Historic Places for its depiction of the Carpenter Gothic architectural style. More recently, the church was placed on the Vermont African American Heritage Trail which explores the lives and stories of African Americans in Vermont and those dedicated to issues of freedom and equality. ## **Department Updates**

**Public Works:** The Town of Colchester will be concluding our local administration of the State Potable Water Supply and Wastewater Permitting Program as of April 1, 2023. We will no longer accept wastewater permit applications, certifications, I/A reports, or other program



related materials as of March 1, 2023. On and after March 1, 2023, applications may be submitted to the State of Vermont wastewater program through their ANR Online website. These permit applications will likely be reviewed after, and for certain not issued until April 1. If failed systems are found between March 1 and March 31, we are asking folks to please reach out to the Town and we can discuss the best way to expedite applications for replacement systems. Certifications, annual reports, and I&A related materials will not be accepted by either party between 3/1 and 3/31. Requests for test pit attendance scheduled on or after March 1, 2023 should be sent to the State of Vermont's regional engineers in the Essex Regional Office. The rationale for this change is that the locally borne costs outweighed the benefits of local administration of this program given that the State of Vermont would operate the program within Colchester as it does in all but one other community in the State.
