Manager's Message Aaron Frank, Town Manager

A <u>resolution</u> acknowledging Police Chief Doug Allen's retirement and honoring his 39 years of service to the Town of Colchester was shared at last night's Selectboard meeting.

Additionally, Lieutenant Pete Hull has been named interim Police Chief until a Police Chief is identified and onboarded. Lieutenant Hull has been with the Town for 33 years, has served as a Lieutenant for the past five years, and has a Bachelor's degree in Business Management from Champlain College.





Colchester voters approved the Colchester Recreation Center on Town Meeting Day 2023. The vote followed 90 public meetings over 22 years, including a prior vote to purchase the land for the Recreation Center in 2004.

Town staff put the project out to bid first to qualify contractors and then to receive bids from qualified contractors. Three firms were asked to be qualified, and two were: ReArch and Engelberth. Two bids were received, and Engleberth was the lower bidder. On September 26th the Selectboard voted to enter into a contract with

Engleberth as a general contractor. This was an expected step towards construction and opening the Colchester Recreation Center by Spring of 2025.

- Modifications of rules and regulations governing the Town-owned cemeteries, including costs of interment and plots, and recommendations for expansion and landscaping
- Recommendations for which capital improvements should be made to the cemeteries and their relative priority
- Long-term planning for how to respond to future demands for cemetery services

The Conservation Commission is concerned with the public awareness, education, and preservation of Colchester's natural areas; water quality of rivers, ponds, and Lake Champlain; wildlife habitats; and beautification of the Town. Annual activities include:

- Green Up Day coordination
- Colchester Blooms! to raise funds for planting flowerbeds at high-traffic sites
- Maintenance of the rain garden on Holy Cross Road
- Site visits to Town natural areas to plan future projects and assess natural resources for reports to Lake Champlain Land Trust
- Attention to water quality, stream protection, conservation and related areas and responds to special project requests from Town officials
- Completed projects include: Care of the Urban Forest Project through the Vermont Urban and Community Forestry Program. This program assists with master tree planning and tree inventory. It also provides volunteer training in the maintenance and care of Town trees; as well as hosting the Rain Barrel Workshop
- What CCC Values: Creative thinking and new ideas regarding ways to address conservation in Colchester
