Blakely Road Sidewalk Closure: Starting on Monday, January 22nd, the sidewalk on Blakely Road will be closed in the vicinity of Laker Lane. A sidewalk detour will be in place to direct pedestrians and bicyclists to utilize the bike path between the Middle School and Bayside Park. The sidewalk closure will be in place for approximately three weeks.



Town Meeting Day Information: The Annual Town Meeting will meet in-person and will be held Monday, March 4, 2024 at 7:00 p.m. at the Colchester High School Auditorium. Voting by Australian Ballot will take place Tuesday,

Broadband Update: While Act 71 created and offered public funds for broadband expansion around Vermont, project requirements have limited opportunities for broadband expansion within Colchester. Town staff has remained in contact with internet service providers in an attempt to learn about their potential expansion plans in Colchester, and earlier in 2023, Consolidated Communications began running fiber

within several Chittenden County towns, including Colchester, under the name Fidium Fiber. By July 2023, Fidium had run fiber to approximately 1,300 addresses in Colchester.

After the recent Fidium Fiber expansion, only about 1% of all addresses in Colchester are still "unserved" or "underserved" on the State list of broadband service. Based on a review of the most current State information, considering the fiber now in place and available through Fidium Fiber and after reviewing the data in detail, there are only 51 occupied properties (0.78%) in Colchester which do not have at least cable speed 25/3 Mbps internet. Town staff will continue to monitor funding availability and opportunities to partner with other towns or businesses to improve the quality of internet service available to residents and

businesses. Broadband of at least 100/100 Mbps is regarded as the level of broadband service needed to truly meet today's demands (fiber offers 1,000 Mbps), and significant investment would be needed over time to bring that level to Colchester. Town Clerk's Office: Attention Colchester dog parent! It's time to renew your dog's annual license.

Fees:

Fixed dog \$15.00 Non-fixed dog \$20.00

To avoid an additional \$5.00 fee, license your dog before April 1st.



The state of Vermont requires all dogs to be licensed with their town. A current rabies certificate along with proof of spay/neuter and fee is needed to issue the license and tag.
