Below is a letter from your Selectboard:

Dear Colchester Voters, Residents, and Taxpayers:

We, your Selectboard, are writing to provide information on the Town of Colchester's FY 25 Municipal Services Budget to be voted on for Town Meeting Day 2024.

The budget maintains the current level of municipal services and recognizes that growth in Colchester requires additional resources to sustain its present level of service to the community. Of the 25 service areas that make up the budget, three have reduced expenses, one remained the same and four increased by \$5,000 or less. Along with the previously approved capital items, the tax impact of the municipal services budget is a $\underline{4.6\%}$ increase to municipal services property taxes.

The changes needed to maintain the current level of service to the community include:

- **Two additional police officers,** to reduce our calls per officer making time for community policing
- Additional Rescue Member (Advanced Emergency Medical Technician or Paramedic) due to increasing calls and the need to provide the Assistant Rescue Chief with time to support the staff
- **Police Support Services Manager** to oversee public safety communications (dispatch) and records (which helps prepare cases for court) providing a Lieutenant more time to manage Police services
- Human Resource Coordinator to address sustained higher rate of employee turnover due to societal changes, especially public safety which is more than half our employee base
- Information Technology Manager to support public safety and other departments with regard to cybersecurity threats, departmental specific software and network connectivity
- **Firefighter** that was hired in June of 2023
- **Asst. Fire Chief** moved from half- to full-time to better support the career and volunteer staff

We have continually attended to the needs of the Town's primary public safety services: police, fire, and rescue. Since FY 20, the budgets we have proposed, and that voters have approved, have improved these core municipal service budgets as follows:

- Police: + \$1,079,161,30%
- Fire: + \$280,473, 33%
- **Rescue:** + \$255,620, 38% (all of which came from non-tax rescue billing revenues)

We make the most of non-property tax revenues and prioritize fiscal sustainability. More than half of the capital expenses in FY 24 were supported by grants. Careful management of the budget in FY 23 allowed revenues to exceed expenses, and because of this, \$351,000 in fund balance from FY 23 will be used as revenue to offset tax increases in FY 25.



The Champlain Water District (CWD) Income Survey #2: CWD, an independent, special-purpose government, which provides water to much of Colchester is trying to

collect income data in an effort to obtain state and federal funding, which we all contribute to. If CWD succeeds with such funding, it will help keep the price of water down. This is



CWD's second attempt at collecting income survey responses. A sample of water customers will receive a survey in the mail notifying them of the survey. CWD encourages participants to complete the survey online, but participants may also elect to complete the printed form and mail it back to CWD in the provided postage-paid envelope within two weeks of receipt.

CWD understands that being asked about your income is intrusive. CWD assures you that your answers are completely confidential and will only be used to calculate an average of income in our community. Remembering Colchester's Buffalo

Soldiers: Especially during Black History Month, we proudly honor and remember the Buffalo Soldiers who served at Fort Ethan Allen. The Vermont Historical Marker located at the Fort reads as follows:

"In July of 1909, the 10th U.S. Cavalry arrived at Fort Ethan Allen for a four-year assignment. Nicknamed the 'Buffalo Soldiers' during the American Indian Wars, the 10th Cavalry was one of the first peacetime all-black regiments established in the regular U.S. Army after the Civil War. Highly decorated and famous for their professionalism and contributions during the Spanish-American War in Cuba, the 10th Cavalry became popular with the local community, hosting many performances, parades, and sporting events. After the 10th Cavalry suffered heavy losses in Arizona during a skirmish with Mexican troops in 1916, residents of Winooski expressed their grief in a condolence letter to the regiment's leader."


