Town-wide Reappraisal Information:

On August 27th, 2024 the Colchester Selectboard moved to authorize the Town Assessor to enter into a contract with Vision Government Solutions, an appraisal firm certified by the Vermont Department of Taxes to reassess all taxable parcels within the boundaries of the Town of Colchester, in compliance with a Vermont Department of Taxes issued Reappraisal Order.

The State mandates reappraisals if a town's Common Level of Assessment (CLA) decreases below 85%. Since 2020, the real estate market has increased significantly, and the Town's CLA has decreased to 66.8 %, falling below this threshold. In 2022, the State mandated a Town-wide reappraisal for Colchester. The reappraisal will be completed for the fiscal year beginning July 1, 2026.

The reappraisal itself is revenue neutral and will not increase property taxes, instead, adjusts property to the fair market value. Assuming the same level of municipal service or State Education Tax funding needs, tax rates are simply lowered to yield the same amount of taxes. Taxes would not increase to yield the same amount of municipal service or State Education Tax Funding. If a property or properties increase in value more than other properties the tax for that property will increase because of the increase in value above and beyond other properties. This generally happens by property class, very broadly, such as residential vs. commercial properties.
