Election Update-Watch for Mailed Ballot

We have received notice that the Colchester registered voters' absentee/early ballots are being mailed by the Secretary of State's Office in the next few days. Be on the watch for your ballots in the US Postal Mail.



Your voted ballot can be returned to the Town Clerk's Office by using the GREEN Drive-up Drop Box between Town Hall and Police Dept. at 781 Blakely Rd. It is available 24-7 from now to November 4th at 4:30pm. Our office hours are 8:00am to 4:30pm if you would like to drop off at the Clerk's counter. The absentee/early ballot mailing includes a postage paid return envelope if you prefer to use the US Postal mail.



Malletts Bay Sewer Construction Update

The Malletts Bay Sewer Project is in full swing and we appreciate the traveling public's patience and understanding as we complete this important work. Construction crews are on schedule and are planning to wrap up this season's work in mid to late November.

West Lakeshore Drive

The contractor performing this work has been right on schedule and is currently working in the area of 135 West Lakeshore Drive. If we continue to enjoy good weather for construction activities, the contractor should have the main sewer line and service connections to the edge of the public right-of-way on West Lakeshore Drive fully installed before winter shutdown. Prior to winter shutdown – regardless of where the contractor ends their work for the season – they are responsible for completing pavement repair and restoration for all disturbed areas. Because of the nature of this project, any pavement restoration work installed previously would have been disrupted when the contractor began night work, as they did in mid-September. We are also mindful of the overall disruption that this project requires, and for that reason having the contractor spend their time restoring the roadway immediately after disturbing it would divert resources away from finishing the main line work, ultimately prolonging the disruption beyond what we feel the community will tolerate. We understand the driving surface is not uniform and ask that the traveling public be mindful of the 25MPH speed limit. The entirety of West Lakeshore Drive will be paved as part of the Town's regular Capital Paving Program once the Sewer project is fully complete. After winter shutdown, the contractor will resume work on East Lakeshore Drive and there will be a detour in place using Williams Road to reduce travel delays.





The Town is exploring with the contractor solutions to provide efficient movement of traffic through the construction zone in relation to the functioning of the traffic signal at the Lakeshore/Blakely (Bayside) intersection.

Blakely Road

The contractor performing this work has also been right on schedule and is currently working in the area of 1987 Blakely Road. If we continue to enjoy good weather for construction activities, the contractor should have the majority of the sewer force main along Blakely Road installed prior to the end of the season. Properties to be affected by construction activities will be contacted by a member of the project team ahead of any impacts. The pump station near Interstate-89 is partially installed, with the remaining components currently being manufactured and delivered to the site in the next two weeks. The traveling public should continue to expect alternating single lane traffic during work hours and we'd like to remind drivers of the 35MPH speed limit along most of the roadway and the 25MPH speed limit in areas designated as school zones.
