Champlain Water District Water Conservation Notice


On **Wednesday, April 16, from 8:00 a.m. to 6:00 p.m.** Champlain Water District (CWD) will be shutting down the Water Treatment Plant due to ongoing facility construction.



On this date, CWD requests that customers **stop all non-essential water usage** during this 10-hour shut down period. This includes all outdoor water usage and non-essential indoor water usage such as laundry and using the dishwasher.

This conservation effort will allow CWD to maintain adequate storage volumes of water for any potential emergency.

Consolidation of Community Justice Services

This article will briefly explain current community justice services, legislative changes, re-entry services, pre-charge services, and the future of community justice services.

Current Community Justice Services: The Colchester Police Department partners with the Essex Community Justice Center (ECJC) to provide restorative justice to the community. The goal of restorative justice is to give an alternative route for cases, rather than prosecution and the traditional criminal legal system. Restorative justice keeps the focus on "who was harmed" and "how can the harm be repaired" instead of "who did it" and "what should we do to them". ECJC does this by allowing law enforcement officials to refer low-level offenders to their pre-charge program. In this program, outreach is done to all victims/harmed parties and those responsible for the harm will go in front of panels comprised of trained community volunteers and are held accountable for their actions through the creation of an Agreement that addresses the harm caused and ways to avoid making similar mistakes in the future. ECJC also offers reentry services for individuals returning to their communities after incarceration. ECJC is funded with state grants and ongoing operating funds from the Towns of Colchester and Essex.

Legislative Changes: Chittenden County has four community justice centers. The Vermont State legislature passed a bill in 2024 to consolidate community justice with one center in each county and which may provide some administrative efficiencies for the State and could improve community justice in other counties where there are fewer services. For ECJC, we will see changes to the way its restorative justice programs are funded and are set to consolidate some of the services it provides to our community.

Re-Entry Services: ECJC's reentry program currently receives funding from the Vermont Department of Corrections. Starting in Fiscal Year 2026, the Department of Corrections is opting to have a single entity provide reentry support programs for Chittenden County and will end funding to ECJC's program. This funding has been awarded to the City of Burlington's Community Justice Center and the Burlington CJC will provide re-entry services beginning in July 2025.

Pre-Charge Services: Also beginning in Fiscal Year 2026, the ECJC's pre-charge program will receive funding and oversight from the Attorney General's Office instead of the Department of Corrections. Effective at the start of Fiscal Year 2027, pre-charge funding will only be provided to the Burlington Community Justice Center. Following this change, the City of Burlington and the Attorney General's Office have indicated that they support operating pre-charge programs locally in Chittenden County towns. The details of this plan are still in the works.

Future: The Colchester Selectboard has asked for the programs to continue to remain community-based in light of these changes. Further updates will be provided as these changes are implemented.

Thinking about the Future: Chittenden County Draft Future Land Use Map

Chittenden County Regional Planning Commission (CCRPC) is working with cities and towns to implement a regional Future Land Use Map with growth assigned to each community according to state law. This map, once adopted, will generally guide how land in the region will be used in the future. The land use categories on the map are defined in state law, and CCRPC is tasked with





determining how the categories apply in the region. CCRPC is seeking input from the public to help guide the mapping work.

Add your voice to the conversation about Colchester's regional future land use map at an upcoming mapping workshop! At the workshop, you will learn about the Future Land Use Mapping process, have a chance to ask questions, and be able to view and provide feedback on the map.

This mapping project stems from Act 181, passed into law June 2024. Act 181 overhauls Vermont's planning framework for coordinating state, regional, and municipal land use. For more information about Act 181, please see the following materials:
