Colchester Log Schoolhouse Opens for the Summer

This image shows part of the restoration process of the Colchester Log Schoolhouse. This structure was one of the earliest schoolhouses in Colchester, built circa 1815. The 24' x 28' building is made of square hewn white pine measuring 7" wide and up to 15" high. In 2001, the Colchester Historical Society formed a committee to save and renovate the building. Today, it functions as a lovely visitor information center and museum that showcases some of our Town's wonderful history and heritage.

Come visit this summer and take a lovely step back in time! The Colchester Log Schoolhouse is open to visitors June 6 through Labor Day, Fridays-Mondays, 10 a.m. - 2 p.m. It's located at Airport Park at 500 Colchester Point Road. Parking and admission are free, although donations are always appreciated.

Exit 16 Diverging Diamond Interchange Project – An Update from the Vermont Department of Transportation

The Vermont Department of Transportation (VTrans) announced that work on the Diverging Diamond Interchange Project (DDI) is scheduled to resume later this summer.

Phase 1 of the project began in Winter 2023 and concluded in Fall 2023. Construction on Phase 2 of the project is anticipated to begin later this summer.

VTrans is constructing a Diverging Diamond Interchange along the U.S. Route 2/7 corridor, in the vicinity of I-89 Exit 16. A DDI is a modern interchange design that can relieve traffic congestion and improve safety for drivers, bicyclists, and pedestrians.
