I understand that my membership is not active until I have completed payment, reviewed the membership guide and completed all necessary paperwork. Whereas, the undersigned has requested the use of services, equipment, or facilities belonging to or under the auspices of the Town of Colchester, Vermont, and to engage in activities for the exclusive benefit of the undersigned: and Whereas, the Town of Colchester does not wish to be liable for any damages arising from personal injury or property damage sustained thereby: Now therefore, in consideration of the mutual promises and other good and valuable consideration, the undersigned does hereby for themselves, their heirs, executor, employers, successors or administrators, and personal representatives; A. Assume full responsibility for any personal injury, loss of service, or any damage to his/her personal property which may occur directly or indirectly in the course of participating in Recreation Center Activities B. Fully and forever release discharge and hold harmless the Town of Colchester, its agents, officials, employees, elected officials, volunteers, and instructor from any and all claims, demands, damages, liabilities, rights or action, or causes of action, present or future, whether the same be known, an anticipated or unanticipated, resulting from or arising out of the above described activity. C. Agree that it is the intent of the undersigned that this release and indemnity agreement shall be in full force & effect any time after the execution hereof.

The Colchester Parks & Recreation Department reserves the right to suspend or cancel any form of membership or participation in any program if a person's behavior is considered detrimental to the best interests, health, or safety of other members, visitors or staff. For example, continual refusal to cooperate and/or follow rules and regulations, or endangering the health and safety of any person. No refund will be given for a revoked membership or removal from a program at the Colchester Recreation Center. Immediate removal from the building will be enforced for engaging in the following: Accessing a part of the Colchester Recreation Center without proper membership or pass; allowing others to enter the Colchester Recreation Center without a purchased membership or pass; multiple, repeated or single significant violations of the Colchester Recreation Center's Code of Conduct

Refusal to adhere to instruction given by staff members; use of any tobacco, alcohol, illegal substances, or any other recreational products that may alter a person's mindset; violence or fighting; bringing firearms, knives or other dangerous weapons or substances in to the Colchester Recreation Center; theft, criminal activity, violations of laws or ordinances; other conduct deemed detrimental to others or the facility. Memberships can be put on hold for up to 90 based days on medical reasons or extenuating circumstances. Holds must be placed 30 days prior to your billing due date, otherwise suspension will be applied to the next scheduled payment. Members must complete a Membership Hold Form and return it to the front desk or via email to crc@colchestervt.gov for approval before a hold is put on your account. We will not issue a refund for any 3-month memberships, daily drop-ins, or punch pass once the transaction has been completed. Annual memberships can be cancelled after 90 days of sign-up, we do not allow cancellations prior to the 90 days. You must provide 30-day notice by completing and submitting the cancellation form.

By participating in a Town of Colchester Recreation program, participants may be photographed for future publications or recognition of events. By signing up for a program or membership you are willingly signing a waiver that grants the Colchester Recreation Department permission to use your photo to promote programs. Pictures taken may be used up to 10 years after the photo was taken. By signing you have read the membership guide and adhere to the rules and regulations set forth in that document.
